Standard Operating Procedure for issue of pre-packs by nurses on the Surgical Day-case Unit, Ward 3A, Ward 4C and EDU

- Prepacks can only be dispensed by a nurse who has completed training in dispensing of pre-packs Prepacks must be prescribed by an Independent Prescriber (usually a doctor or qualified ANP).
 Pre-packs can be issued by nursing staff out of hours or in normal working hours to prevent significant delays during Pharmacy opening times
 - a. See Appendix 1-3 for list of pre-packs which are authorised to be issued via this SOP
 - b. Nurses who have completed Patient Group Direction (PGD) training and competencies are able to issue pre-packs of analgesia under the PGD (i.e. without a prescription). See relevant PGDs for further information.
- 2. Check the instructions on the prescription are appropriate for the product selected using the BNF for Children. If there are any concerns, contact the prescriber, send to pharmacy for dispensing or contact the on-call pharmacist
- 3. Select the appropriate pre-pack and complete the label with the instructions on the prescription, the patients name and the date supplied from the ward.
- 4. Select the appropriate patient information leaflet.
- 5. Record on the printed discharge summary "Pre-pack supplied from" (state the area issuing the pre-pack) and add your signature to this statement.
- 6. Obtain a check of the information written on the label by a second qualified nurse who has completed training in issuing of pre-packs. This nurse will also sign the discharge summary
- 7. File the signed copy of the discharge summary in the patient's case notes
- 8. ONE pre-pack should be sufficient for the majority of prescriptions. Additional pre-packs should only be provided in the following circumstances
 - a. if ointment or drops are required for both eyes
 - b. if the patient is prescribed a high dose of an antibiotic
- 9. Order further supplies of pre-packs from pharmacy using the standard order form
- 10. Order further supplies of patient-information leaflets from the Pharmacy Admin Team on Ex 2535

Insulin prepacks on EDU can only be issued under the guidance of a diabetic nurse specialist against a valid prescription for the appropriate insulin required. **Appendix 1**
